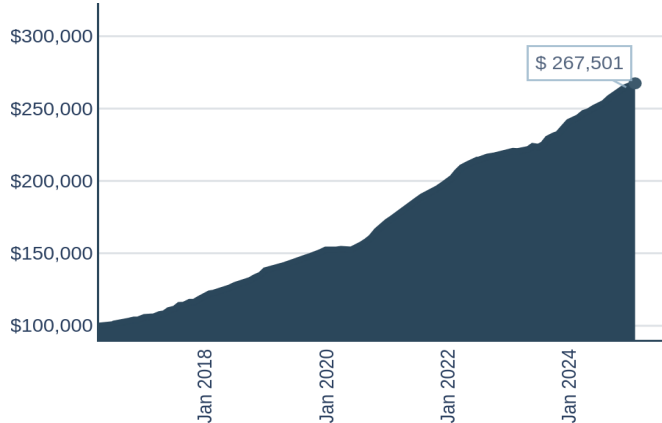

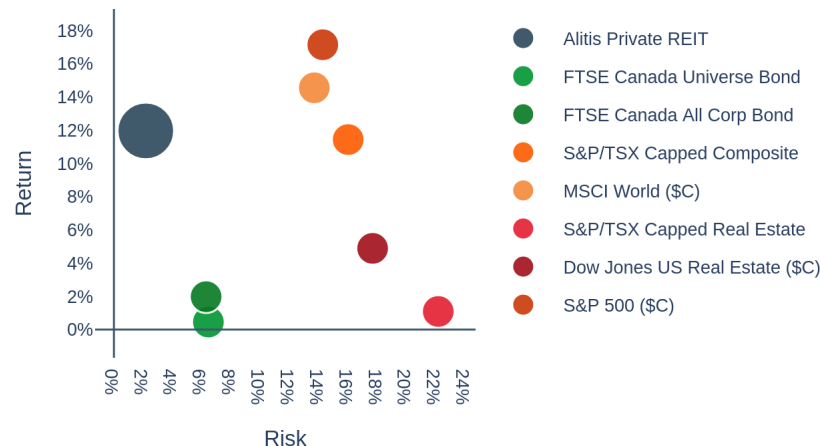
Growth of \$100,000 (Since Inception)

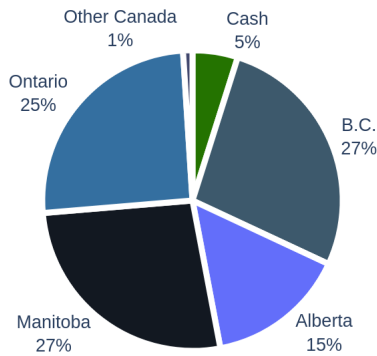

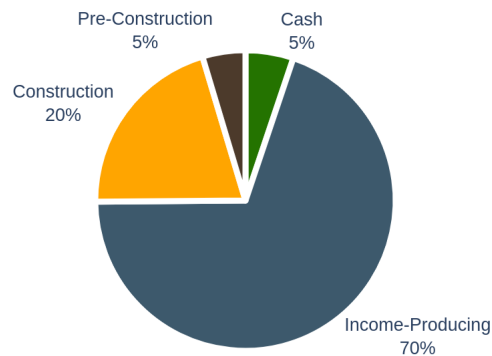

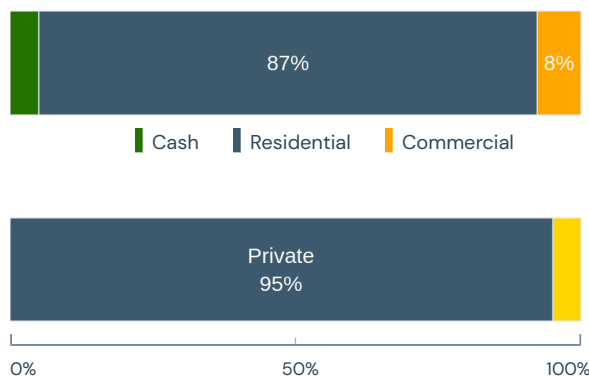
Regional Breakdown
